

Costa Rica: A Trove of Tropical Birds—and More February 3-14, 2024 Optional Extension: February 14-17, 2024

COST SHEET

Members' rate is for members of Nature Forward. Nonmembers are encouraged to join, but may choose to pay nonmembers' supplement of \$100. We will try to provide a roommate for anyone who would like to share a room. We will not ask a nonsmoker to share a room with a smoker unless the nonsmoker is willing to do so. If a roommate cannot be found, the trip participant using a single room will be required to pay the single room supplement. *NOTE: The number of single rooms is limited.*

- COSTS INCLUDE: All ground transportation in Costa Rica using a private mini-bus with professional driver, accommodations, admissions, one boat trip, all but two meals, expert leadership, and trip materials.
- NOT INCLUDED: Round-trip transportation from your home to San Jose, Costa Rica and your return trip home; beverages other than those included with meals; gratuities; baggage handling; telephone calls; special services; and other items of a personal nature. Tips are customary in Costa Rica, and most travelers choose to give the Costa Rican guides generous tips.
- REGISTRATION: Register by filling out the attached registration form as well as the COVID Policies page. Mail them to Nature Forward (attention: Pam Oves) with a \$500 per person deposit. We're sorry, but we cannot accept credit card payment for our travel programs. Space is limited to 12 and registration is by mail-in only. Registration deadline is Friday, October 20.

FINAL PAYMENT: Final Payment (full cost, less deposit) is due Friday, November 3.

- CANCELLATION: Fees less a \$200 administrative charge will be refunded to registered participants who cancel prior to the registration deadline on Friday, October 20. Refunds for later cancellations are based on non-refundable deposits we may have paid and finding a replacement for your spot. If a replacement is found, only the \$200 charge will be withheld. Cancellation notice must be received in writing at least 30 days before the scheduled departure date to guarantee any possible refund. We strongly recommend reviewing and securing travel insurance for all of our trips.
- AIR TRAVEL: Participants are responsible for arranging their own flights to and from San Jose, Costa Rica. Arrangements for air travel may be made through a travel agent, directly through the airlines, or by internet. We will send recommendations for air travel to all registered program participants. Let us know if you need guidance. *Do not purchase non-refundable air tickets until assured by us that the trip will run as planned.*
- PRICING POLICY: All prices are subject to change. If we are forced to increase the price, you have the option to cancel with full refund.
